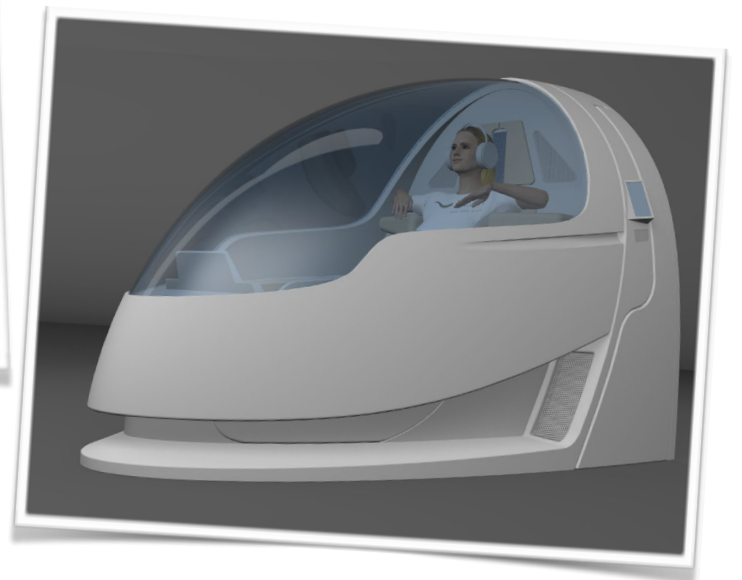

The "Life Wave" device consists of hardware sound wave emitters and software life waves. The sound wave emitter is a device capable of playing ultra-low frequency sound waves ranging from 18Hz to 3000Hz. This device represents a revolutionary invention in terms of functionality, material, and structure.

The primal energy of the universe, known as "qi," is manifested through waves, with sound waves being a carrier of this energy. Sound waves belong to the realm of non-material and also fall within the scope of music therapy. Through resonance, it addresses the current medical challenge of "microcirculation disorders."

Why can the "Life Wave" address various complex and chronic health issues? Because microcirculation disorders are the root cause of many diseases. The Life Wave can effectively and rapidly resolve this global challenge of microcirculation disorders.

According to the biophysical framework of life substances, human blood is tangible and belongs to biochemical characteristics at the cellular and molecular levels. When blood vessels are blocked, it's called microcirculatory disorders.

If the blockage occurs in the heart, it's called a heart attack. If it's in the brain, it's called a stroke. Blockages in capillaries are called tumors. If it's in the liver, it's called a tumor.

In the uterus, it's called a fibroid. In the breasts, it's called hyperplasia. If it's in the thyroid, it's called a nodule. Acne occurs when there's a blockage on the face.

Skin blockages are called nodules. Varicose veins occur when there's a blockage in the legs.

Cysts occur when there's a blockage in the mucous membranes. Neck pain is often associated with cervical spondylosis, which is caused by blockages in the neck.

Especially during sleep, blood flow slows down, making individuals with cardiovascular and cerebrovascular diseases more prone to accidents, which is the reason behind it.

Life Wave A, using one device (with four built-in sound wave speakers). It has the function of preventing and treating high blood pressure, various pains, cervical spondylosis, lumbar spondylosis, and various bone and joint diseases.

Method of Use for High Blood Pressure: Every morning, place the device horizontally on the ground and place both feet on the sound wave speakers of the device for one hour. Then, place the device vertically on a chair and sit on it, focusing on positioning the tailbone towards one of the sound wave speakers at the back (sitting upright for optimal effect) for one hour. At night, place the device horizontally at the foot of the bed and set it for one to three hours. The device will naturally stop when time is up after you falling asleep.

After ten days of use, there will be various adjustment phenomena in the body, and blood pressure will begin to decrease. After one month of use, blood pressure will decrease to normal levels. After six months of use, blood pressure will reach normal levels.

Method of Use for Various Pains and Bone and Joint Diseases: Place both feet on the sound wave speakers of the device for one hour, then place the device vertically on a chair and sit on it, focusing on positioning the tailbone towards one of the sound wave speakers at the back (sitting upright for optimal effect) for one hour. Various pains will be relieved. Then, place or tie the device to the painful area for one hour, and the various pains will disappear to varying degrees. Different pains and different populations require different usage times. With increased usage days, pains can be alleviated and disappear.

Life Wave B, utilizes two devices (each equipped with eight sound wave speakers). It is effective for preventing and treating diabetes, prostate issues, breast diseases, varicose veins, thyroid nodules, gynecological conditions, uterine fibroids, constipation, as well as male and female reproductive problems.

Usage Instructions: Every morning, place one device horizontally on the ground and rest both feet on the sound wave speakers of the device for one hour. Then, place the second device vertically on a chair and sit on it, ensuring that the tailbone is aligned with one of the sound wave speakers at the back (sitting upright for optimal results) for one hour. At night, position one device horizontally at the foot of the bed, which can be set to operate for one to three hours. The device will naturally stop after falling asleep. The second device can be

placed on the abdomen, and usage time and energy levels can be adjusted according to personal preferences to achieve natural sleep.

After ten days of use, the body will experience various adjustment phenomena. Symptoms will begin to alleviate and lessen after thirty days of use. After six months, a recovery rate of 70% can be achieved. After one year, the recovery rate can reach 80%. After two years, the recovery rate can reach 96%.

Life Wave C, utilizes a bed device equipped with thirty sound wave speakers. It is effective for preventing and treating cancer, heart disease, coronary artery disease, heart attacks, shortness of breath, palpitations, strokes, cardiovascular diseases, avascular necrosis of the femoral head, herpes zoster, microcirculation disorders, and more.

Usage Instructions:

Use for one to three hours in the morning, and three hours at night during sleep.

After one month of use, various symptoms will begin to alleviate.

After one year, a recovery rate of 50% can be achieved. After two years, the recovery rate can reach 70%. After three years, the recovery rate can reach 90%.
